**ORDER**

**Sub.: Implementation of Graded Response Action Plan in Delhi-NCR- steps to be taken**

This is in continuation to the Order No. A-19014/45/CAQM-GRAP/2020-21 of the Sub-committee, dated October 28, 2021. The Sub-committee convened a meeting on November 08, 2021 and reviewed air quality status as well as meteorological and air pollution forecast. As per IMD's forecast, winds are expected to be North Westerly for the next 5 days which may possibly lead to high contribution of stubble burning. In addition, unfavorable meteorology may cause air quality to fluctuate between 'Severe' and higher end of 'Very Poor' category in the coming days.

Based on the decisions made by the Sub-committee, following actions are to be strictly enforced by concerned agencies:

1. Actions under 'Severe' category, in addition to steps listed under 'Very Poor' and 'Poor' to 'Moderate' AQI categories (enclosed for ready reference) should be implemented with immediate effect in Delhi-NCR-
  - a. Increase frequency of mechanized cleaning of road and sprinkling of water on roads. Identify road stretches with high dust generation.
  - b. Ensure that all brick kilns remain closed in Delhi-NCR as per the directions of Hon'ble NGT.
  - c. Ensure closure of all Hot Mix plants and Stone Crushers in Delhi-NCR.
  - d. Maximize generation of power from existing natural gas based plants to reduce operation of coal based power plants in the NCR (Badarpur power plant already shut down)
  - e. Intensify public transport services. Introduce differential rates to encourage off-peak travel.
2. States to disseminate information about air pollution levels and for creating awareness among citizens regarding steps to minimize air pollution.
3. Implementing agencies, at appropriate level, must closely monitor actions taken and submit daily report to concerned SPCBs /PCC, which will review and further submit reports to CAQM and CPCB.



**Sub.: Implementation of Graded Response Action Plan in Delhi-NCR- steps to be taken**

This is in continuation to the Order No. A-19014/45/CAQM-GRAP/2020-21 of the Sub-committee dated October 18, 2021. The Sub-committee convened a meeting on October 28, 2021 and reviewed air quality status as well as meteorological and air pollution forecast, made available by IMD. It was noted that winds are North-Westerly until the morning of November 01, 2021. Further minimum temperature is likely to drop to 14-15°C with increased moisture, which is unfavorable for dispersion of pollutants. It is likely that air quality may fall in 'Very Poor' AQI category.

Based on the decisions made by the Sub-committee, the following actions are to be strictly enforced by concerned agencies:

1. Following actions under 'Very Poor' category, in addition to steps listed under 'Poor' to 'Moderate' AQI category should be implemented with immediate effect in Delhi-NCR:
  - a. Mechanical/vacuum-based sweeping of roads to be carried out daily.
  - b. Ensure water sprinkling along with use of dust suppressants (at least every alternate day) on roads to arrest road dust especially at hotspots, heavy traffic corridors, vulnerable areas (before peak hours) and proper disposal of dust collected in designated sites/landfills.
  - c. Regular inspection for strict enforcement of dust control measures must be ensured at construction sites.
  - d. Ensure uninterrupted power supply to discourage the use of Generator sets.
  - e. Stop use of diesel generator sets [except for emergency purposes (Annexure I)]
  - f. Enhance parking fee by 3-4 times

- g. Increase bus and metro services by augmenting contract buses and increasing frequency of service
  - h. Stop use of coal/firewood in hotels and open eateries
2. Citizens to take actions to prevent air pollution, such as:
- a. Residential Welfare Associations and individual house owners to provide electric heaters during winter to security staff to avoid open burning by them.
  - b. Keeping PUC certificates up to date.
  - c. Keeping engines of cars/ bikes/ scooters properly tuned.
  - d. Maintaining proper air pressure in tires of cars/ bikes/ scooters
  - e. Adherence to lane driving
  - f. Optimize use of private vehicles
  - g. Not disposing waste /garbage in the open spaces
  - h. Avoid dust generating construction activities during months of October to January, if possible.
  - i. Reporting air pollution activities through SAMEER App, social media platforms and other public grievance portals
3. States to disseminate information about air pollution levels and for creating awareness among citizens regarding steps to minimize air pollution.

All the concerned agencies must take steps as mentioned above and submit action taken report to the Member Secretary, CAQM.

**ORDER**

**Sub.: Implementation of Graded Response Action Plan in Delhi-NCR- steps to be taken**

The Commission for Air Quality Management in NCR and Adjoining Areas, constituted a Sub-committee for operationalization of Graded Response Action Plan (GRAP) and issuing necessary orders to the effect, vide order dated October 14, 2021 (Copy enclosed for ready reference).

The Sub-committee held two meetings on October 12 & 18, 2021 and reviewed air quality status as well as meteorological and air pollution forecast, made available by IMD. It was noted that air quality was in the 'Satisfactory' AQI category. North-Easterly winds with speed of 10-12 Km/hr will prevail till October 20, 2021 thereafter, winds will become North-Westerly with speed of 8-10 Km/hr. In the period between 21<sup>st</sup> to 24<sup>th</sup> October, air quality is likely to fluctuate between 'Moderate' to 'Poor' AQI categories.

Based on the decisions made by the Sub-committee, the following actions are to be implemented by concerned agencies with immediate effect:

1. Actions under 'Poor' to 'Moderate' category-

- a) Stringently enforce/stop garbage burning in landfills and other places and impose heavy fines on person responsible
- b) Stringently enforce all pollution control regulations in industries and thermal power plants
- c) Ensure that all brick kilns remain closed in Delhi-NCR as per the directions of Hon'ble NGT.
- d) Ensure periodic mechanized sweeping and/or water sprinkling on roads with heavy traffic and dust generation potential.
- e) Strict vigilance and no tolerance for visible emissions – stop plying of visibly polluting vehicles by impounding or heavy fine.
- f) Strict vigilance and enforcement of PUC norms.



- g) Stringently enforce rules for dust control in construction activities and close non-compliant sites.
  - h) Deploy traffic police for smooth traffic flow at identified vulnerable areas
  - i) Strictly enforce Hon'ble Supreme Court order on diversion of non-destined truck traffic and ensure only trucks registered after 2005 are allowed entry into Delhi.
  - j) Strictly enforce orders of Hon'ble Supreme Court and Hon'ble NGT regarding firecrackers.
2. Implementing agencies should be in readiness for implementation of actions under 'Very Poor' category.
  3. Citizens to take steps to check air polluting activities, such as:
    - a) Keeping PUC certificates up to date.
    - b) Keeping engines of cars/ bikes/ scooters properly tuned.
    - c) Maintaining proper air pressure in tires of cars/ bikes/ scooters
    - d) Adherence to lane driving
    - e) Optimize use of private vehicles
    - f) Not disposing waste /garbage in the open spaces
    - g) Reporting air pollution activities through SAMEER App, social media platforms and other public grievance portals
  4. States/Implementing agencies to disseminate information about air pollution levels and steps to minimize air pollution, for creating awareness among citizens.

All the concerned agencies must take steps as mentioned above and submit action taken report to the Member Secretary, CAQM.
