
WHEREAS, the Hon'ble Tribunal has directed Govt. of NCT of Delhi to pay a sum of Rs. 25.05 Crores only (Rs. Twenty Five Crores and Five Lakh only) as Environmental Damage Charges for damage to the Environment due to failure of various authorities of Govt. NCT of Delhi in discharging their duties (as detailed at S.No. 1 & 2). It was also directed to furnish performance guarantee of the sum of Rs. 52 crores only (Rs. Fifty Two Crores only) for taking necessary steps in next three months.

AND WHEREAS payment of Environmental Damage Charges of Rs. 25.05 Crores only (Rs. Twenty Five Crores and Five Lakh only) has been made to the CPCB by Cheque No. 023959 dt. 24.04.2019.
