OFFICE ORDER

Revised classification of industrial units has been done by State Pollution Control Board, Odisha as per the criteria and guidelines of the Central Pollution Control Board and this Board has brought out office orders from time to time in this regard. Meanwhile, after evaluation by the Committee Meeting held on dtd. 05.08.2024, an office order has been issued vide this office letter No. 14026, dtd. 03.09.2024. In the said order, there is an inadvertently typographical error at Pt. No. C (iv) read as "**Standalone Restaurants (Seating Capacity >36)**" instead of "**Standalone Restaurants**". This shall be read as "**Standalone Restaurants**".

In view of above, this office order is hereby brought out in supersession of earlier order No. 14026, dtd. 03.09.2024 and the following industrial units are classified in the existing list of ROGW for the State of Odisha after the correction.

Category	Industrial Sector
A) Newly Identified Industrial Sector	
Red (SSL-38)	Manufacturing of Integrated Solar Panel
Red (SSL-39)	Manufacturing of Sodium Fluorosilicate
Orange (SSL -19)	Extraction of Cashew Nut Shell Liquid (CNSL) through mechanical pressing and Heating (Other than Electric Heating)
Orange (SSL-20)	Puffed rice (muri) (using coal / wood fired heating system).
Green (SSL-23)	Extraction of Cashew Nut Shell Liquid (CNSL) through mechanical pressing and Heating (Electric Heating)
Green (SSL-24)	FRP Door manufacturing units using GP Resin, Pigment, Cobalt, Hardener (catalyst), glass fiber sheet, wood piece, etc. Manufacturing process involves mixing of chemicals (GP resin, pigment, cobalt and Hardener (catalyst)), molding, pasting (Wood and front / back layers), cutting and finishing. There is no heating or burning of fuel involved in the process.
White	Fragrances formulation unit (without distillation).

B) Industrial Sector included in existing Categories of ROGW	
Manufacture of Linear Alkyl Benzene Sulphonic Acid Plant	Comes under Red- 22 <i>Organic Chemicals Manufacturing</i>
Large Scale Cement Godown	Comes under Respective categories of existing ROGW as per O/o. No. 2704, dtd. 29.02.2024 under <i>Housing & Building Construction Project</i> .
Amusement / Water Parks	
LPG Bottling Industry	Comes under Red SSL -20 i.e., <i>Petroleum products / crude oil storage and transfer excluding cross country pipeline.</i>
Industrial Gas Bottling Industry (excluding LPG)	Comes under Red SSL- 13 i.e., <i>Industrial or inorganic gases namely (a) chemical gases like acetylene, hydrogen, chlorine, fluorine, ammonia, sulphur dioxide, ethylene, hydrogen sulphide, phosphine, (b) hydrocarbon gases like methane, butane, ethane, propane.</i>

C) Industrial Sector exempted from Categorization of ROGW

- i) Brick Kiln & Stone Crusher Units under - Water (PCP) Act, 1974.
- ii) Standalone Vehicle Washing Units without servicing and repairing facility.
- iii) Raw Water Treatment Plant.
- iv) Standalone Restaurants.
